4. Key responsibility areas

Service delivery

- Deliver support programs in accordance with training and the relevant program guidelines.
- Facilitating local carer peer support groups, including training volunteers, and promotional activities.
- Facilitate carer learning from their peers through the sharing of lived experiences.
- Provide facilitation, moderation, and skills development to enable the potential for self-guided peer support sessions.
- Co-facilitate with another peer if required.
- Evaluate the effectiveness of the in-person peer support sessions.
- Develop partnerships with local agencies to establish ongoing promotional activity and warm referral processes for carers interacting with those organisations.
- Collaborate with carers in service planning to ensure service/program is consumer centric.
- Comply with organisational policies, guidelines, relevant legislation, and best practice.
- Ensuring client data is promptly and accurately entered into the CRM (DC2Vue).

Data Reporting and Compliance

- Timely and accurate management of client information including progress notes and attendance.
- Assist with data collection tasks as negotiated.
- Report any incidents or risks into our risk mitigation system (RISKMAN).

Teamwork and Communication

- Develop strong team relationships, fostering positive relationships with colleagues and across departments.
- Collaborate with other team members to ensure integrated and coordinated approaches to addressing client needs.
- Participate in other team projects/activities relevant to the position as required.

Personal accountability

- Compliance with Uniting's values, code of conduct, policies and procedures and relevant government legislation and standards where relevant.
- Cooperate with strategies to actively ensure the safety, protection and well-being of children who come into association with us.
- Ensure appropriate use of resources.
- Work collaboratively with Uniting (Victoria Tasmania) employees and external stakeholders in accordance with Uniting's values and professional standards of behaviour.
- Actively participate in initiatives to maintain, build upon and promote a positive and collaborative workplace.
- Identify opportunities to integrate and work collaboratively across teams.

Qualifications

Experience

- Effective communication in delivering information in specific regional and community settings (previous group facilitation skills will be an advantage).
- Lived experience as a family member/carer of a person with a disability, medical conditions, mental illness or who are frail aged, and the ability to utilise this experience constructively for the benefit of others.

Core selection criteria

- Values alignment: ability to demonstrate and authentically promote Uniting's values.
- Demonstrated ability to provide safe environments for children and young people and protect them from abuse and neglect.
- **Consumer Centeredness** foster, promote and implement a culture that keeps consumers at the centre of everything we do; demonstrates an awareness of and prioritises the needs of consumers; focuses on optimal outcomes for consumers.
- Stakeholder Relationships Strong negotiation and influencing skills; ability to engage, build and maintain strong, mutually beneficial relationships with stakeholders; track record of being able to sustain positive, collaborative and effective relationships; capacity to position Uniting as a trusted advisor to peak bodies and key stakeholders in the sector including government and funding bodies; promotes harmony and consensus through diplomatic handling of disagreements; builds trust through consistent actions, values and communication.
- **Communication** Strong and clear communication skills with the ability to build positive professional relationships with key internal and external stakeholders; excellent interpersonal skills; high level written and verbal communication skills; ability to conduct presentations; ability to prepare high quality business cases and reports.
- Administrative skills: Excellent organisational skills; High level of attention to detail and accuracy; experience in handling sensitive information and maintaining privacy; knowledge of Client Management Systems / Databases or the ability to quickly develop competency in use of such systems; high level computer literacy skills including demonstrated experience in Microsoft Office; well-developed literacy and numeracy skills.
- **Technical knowledge:** Knowledge of community services and supports available to carers and people they care as well as referrals pathways (i.e., MyAgedCare, National Disability Insurance Scheme; demonstrated understanding of legislation, programs guidelines and community services and supports for carers.
