#### 1. Position purpose

The Earn & Learn Internship program is part of the Victorian Government's Mental Health and Wellbeing Workforce Strategy (2021-2024) that outlines a strategic approach to deliver a diverse, skilled and multidisciplinary workforce required for a reformed mental health and wellbeing system.

The Mental Health and Wellbeing Trainee will provide support to consumers, families, carers and supporters in line with Uniting Vic Tas's organisational values for people with mental health and/or alcohol and other drugs challenges. The Mental Health and Wellbeing Trainee will participate in a 12-month traineeship in community mental health services whilst undertaking study in the Certificate IV or Diploma of Mental Health. Services will support Trainees in completing their education and give opportunities to develop knowledge, skills and confidence in a structured and supportive environment.

The Mental Health and Wellbeing Trainee will be responsible for providing support for the day-to-day intake and assessment service functions, outreach support, one-to-one support, group facilitation and will work collaboratively with consumers to achieve their wellbeing and recovery goals. Mental Health and Wellbeing Trainees will be supported with workplace supervision and relevant workplace training and education throughout the employment period.

### 4. Key responsibility areas

### Provide direct support to individual consumers.

- Work withing the principles of recovery orientated, and trauma informed mental health practice including:
  - o Developing routine, daily living skills and capacity for self-care.
  - Understanding and managing consumer's own mental health and/or AOD challenges.
  - Managing physical health.
  - o Addressing stigma and managing issues arising from trauma.
  - Support to maintain or create meaningful activity through participating in community life including education, employment, volunteering, education or community activities.
- Assist in initial needs assessments for people referred to a community mental health service.
- Purposely engage with consumers using techniques including:
  - o Brief intervention.
  - Motivational interviewing and coaching.
  - Family inclusive practice.
  - Trauma informed practice.
  - Conflict resolution.
  - o Behaviour support for dual diagnosis.

#### **Undertake Group Work**

- Plan and develop group work programs that will assist consumers to build their skills, focus on their recovery and work towards transitioning back to their community.
- Assist in the co-facilitation of group activities aimed at building capacity and life skills.
- Deliver group programs as a co-facilitator where needed.
- Evaluate, gather feedback and review group work programs.

## **Provide Support to Families and Carers**

- Engage in ongoing consultation, co-design and coproduction with consumers, carers and support networks. This includes providing services and supports in a culturally sensitive manner for consumers and families from Culturally and Linguistically Diverse (CALD) LGBTIQA+ and First Nations backgrounds and working closely with the service's Lived Experience team including:
  - Assist in the identification and offer support to families, carers and supports as required.
  - Support engagement of consumers to connect with local service providers

- with clinical mental health, physical health, education and employment, eligible entitlements and benefits, housing, transport, recreation and social connections.
- Assist with linkages, relationships, and referral pathways to maintain or create a range of local supports for consumers that support wellbeing and facilitate them living the life of their choosing in their own community.
- Apply a recovery-oriented framework, supporting development of social and living skills, and ensuring identified goals and aspirations align with individualised wellbeing plans.
- Work with families and carers at the time of transition back to community.
- Collaborate with others in the consumer's life including family, carers, mainstream support and other service providers chosen by the consumer to deliver elements of their plans.

## **Support Team Activities**

- Working within the context of the team including:
  - Support for, and ongoing development of, an environment based on shared accountability and effective knowledge sharing.
  - Cooperate with all team members to ensure continuity of care and the provision of an exceptional service offer.
  - Actively participate in team meetings, service planning sessions, and staff development activities.
  - o Other activities as directed to support program and service delivery.
  - Undertake relevant training and professional development including regular supervision.

#### **Administration**

- Keep accurate and complete records of work activities in accordance with legislative requirements and the services' records, information security and privacy policies and requirements.
- Ensure all relevant consumer details and data are collected and recorded.

#### Personal accountability

- Compliance with Uniting's values, code of conduct, policies and procedures and relevant government legislation and standards where relevant.
- Cooperate with strategies to actively ensure the safety, protection and well-being of children who come into association with us.
- Ensure appropriate use of resources.
- Work collaboratively with Uniting (Victoria Tasmania) employees and external stakeholders in accordance with Uniting's values and professional standards of behaviour.
- Actively participate in initiatives to maintain, build upon and promote a positive and collaborative workplace.
- Identify opportunities to integrate and work collaboratively across teams.

#### **Qualifications**

## **Experience**

- Experience working in physical or wellbeing related disciplines such as yoga teaching, personal training, or sports coaching or artistic disciplines such as painting, drawing and sculpting (desirable).
- Proven experience in Community Services, Mental Health, Disability, Social Welfare, Housing Healthcare or Government sectors (desirable)
- Experience and expertise working directly with people with mental health issues, AOD challenges, complex needs and with their families and carers (desirable)
- Demonstrated knowledge and experience in application of theoretical approaches, practices and appropriate service responses including family inclusive practice, trauma informed theory, cognitive behavioral therapy, motivational interviewing and harm reduction therapy (desired)
- A lived experience (as carer or consumer) of mental ill health and recovery (desirable)
- Experience in assessing need and working collaboratively to plan goal orientated recovery using evidence informed approaches and tools (desirable)
- Ability to co-design, co-produce and co-facilitate groups and education support (desirable)
- Demonstrated experience in client notes, reporting and working with a variety of electronic systems (desirable)
